### **OPEN FORUM**

### **COUNCIL MEETING**

- 1. Declarations of interest** were received from Gordon Brown and Karen Payne in respect of their County Council responsibilities.
- The council's Code of Conduct (previously circulated) was **noted**.
- The Minutes of the meeting of 8 July were **approved and matters arising to be dealt with at the September meeting**.

### **Communications**

- Letter of 25 July 2020 from Lord-Lieutenant and High Sheriff. **Resolved:** To invite the Lord-Lieutenant and High Sheriff to send their letters of acknowledgement to the Clerk for distribution by hand within the village.
- Letter of 28 July 2020 from Cadent re gas pipeline. **Resolved:** To forward the information via village mail.

### **Planning**

#### **a) Trees**

- 6. Resolved:** To register a formal objection to the Temporary Tree Preservation Order imposed by RCC re application 2020/0559/CAT to fell 32 cricket bat willows on land to the south of Mill Lane.

7. **Noted:** Application 2020/0719/CAT from Burghley House Preservation Trust Ltd: Exeter Arms. Fell dying larch and unsightly mountain ash. Replant with 2 x Tibetan cherry (*Prunus serrula*) and re-plant. **No objections were raised.**

**b) Buildings**

8. Applications 2020/0693/FUL and 2020/0694/LBA Cornerstone House, 2 Chapel Lane. New gates to driveway, two new windows to north elevation, rooflights and new sliding doors to previously constructed extension to east and one replacement window to west elevation. **Recommended for approval.**

9. Application 2020/0627/FUL Headmasters Cottage, 25 Main Street To move an existing garden shed to a more concealed position. Carry out repairs to the roof and floor with like for like materials. **Recommended for approval**, subject to repairs being carried out as far as possible in similar style and with similar materials to the existing.

10. **Noted** that applications 2019/1001/FUL and 2019/1002/LBA Windmill House Replacement outbuilding with plunge pool were approved by RCC 22 July 2020.

11. **Noted** that application 2020/0570/FUL 3 Morcott Road, Single storey extension was approved by RCC 30 July 2020.

12. **Noted** that application 2020/0506/FUL 15 Chapel Lane, Single storey rear extension and alterations to entrance was approved by RCC 03 Aug 2020 and that the Parish Council's observation had been taken into account. **Resolved:** To write to the Development Control manager at RCC pointing out that the planned extension was in breach of the Barrowden and Wakerley Neighbourhood Plan in respect of Policy BW6
